December President's Column

Do you know why December is an important month in the history of firearms?

The NRA is having its 2017 Annual Meeting April 27 – 30, 2017 in Atlanta, Georgia. Hotel rooms close to the site of the meeting are filling up quickly so you may want to get your reservations as soon as possible. The 2017 SHOT Show is January 17 – 20, 2017 in Las Vegas, Nevada.

The NRA Annual meeting is open to the public. The SHOT Show states on its home page that:

"The SHOT Show is a trade only event. Attendance is RESTRICTED to the shooting, hunting and outdoor trade and commercial buyers and sellers of military, law enforcement and tactical products and services ONLY. The show is not open to the public, and NO one under age 16 shall be admitted (including infants)."

If you go to the NRA Annual Meetings, the SHOT Show or to any gun shows in 2017, you are enjoying your Second Amendment right, a right that Americans value and cherish. So, why is December an important month in the history of firearms? December 15, 1791 the Bill of Rights was adopted after having been ratified by three-fourths of the states. The Second Amendment is included in the Bill of Rights and it states:

A well-regulated militia, being necessary to the security of a free State, the right of the people to keep and bear arms, shall not be infringed."

The right to bear arms has been controversial for decades. It is likely that the debate over the right to bear arms and gun control will continue to be a hot topic for years. We will see what the future holds as at least one new Supreme Court Judge will join the United States Supreme Court during the next four years. Show your support for the Second Amendment and attend at least two more gun events / gun shows then you did in 2016.

~ As the year winds down, it is the time when nominations for a seat on the TCSL Board or a TCSL Officer seat will be accepted. If you are currently sitting on the TCSL Board, then at the December 2016 Board Meeting you will need to announce your decision to run for an officer position. Article 3 Section 9 of the TCSL Bylaws states:

"Any Director who shall elect to run for an office or any Director who cannot remain seated for their full term shall resign their Directorship at the December Board of Directors meeting effective the end of the membership year."

If you decide to run for an officer position, you will still sit on the Board until February 28, 2017, then your term will end and if elected you will take over as an officer at the TCSL March 2017 Board meeting.

At the January 2017 TCSL Board meeting the Bylaws require each committee chair to make a report to the TCSL Board. It is helpful to know what your committee accomplished in 2016, what you would like to accomplish in 2017, what needs your committee will have in 2017, etc. Each committee report should be 5 minutes or less. If you need help getting your report together, please feel free to ask for help.

Lance Monroe is the club manager. It is important to keep Lance up-to-speed on events or activities at TCSL. It is difficult / impossible for Lance to answer questions on the phone or in person if he is not kept informed. *Following is an article on the Risks of using Lead Shot. At our last board meeting there was a discussion on the subject of protecting the creek that runs through the club from lead contaminants. Thought this article might be of some interest. ~ John Kidle/Carol Parent

Risks Associated with Lead Shot

Lead shot was banned for waterfowl hunting in 1991. However it continues to be used widely for shotgun shooting sports (trap, skeet, sporting clays), in ammunition for upland hunting and in fishing tackle.

The ban on lead shot for waterfowl hunting was to reduce the hazard to waterfowl (especially bottom feeders) through direct ingestion of spent lead shot, or through consumption of wounded or dead prey containing lead shot, bullets or fragments. To some degree, our aging creek cover does serve to discourage any waterfowl from feeding from the creek bottom.

Lead from spent ammunition (or lost fishing tackle) is not readily released into aquatic and terrestrial systems, however under some environmental conditions it can slowly dissolve and enter groundwater, making it potentially hazardous for plants, animals and perhaps even people if it enters water bodies or is taken up in plant roots. It is my understanding that the water in the creek, downstream from the creek cover, is periodically tested for lead, and that no measurable lead has been detected.

The primary risk of lead to humans is lead entering drinking water when service pipes that contain lead corrode, especially where the water has high acidity or low mineral content that corrodes pipes and fixtures (i.e. Flint water system). The most common problem is with brass or chrome-plated brass faucets and fixtures with lead solder, from which significant amounts of lead can enter into the water, especially hot water.

Another significant risk of lead to humans is ingesting paint chips and inhaling lead paint dust.

The issue with using steel, tungsten or bismuth shot at our trap range is that many shotguns and/or chokes are only compatible with lead shot. Also, these non-toxic" alternatives are significantly more expensive.
