# WAIVER OF LIABILITY

INSTRUCTIONS: Before participating in any activity at, or using any property belonging to, TRI-COUNTY SPORTSMEN LEAGUE ("TCSL"), you must read and sign this Waiver of Liability.

IN CONSIDERATION FOR being permitted to use or discharge, or view the use or discharge of, firearms and/or bows or being instructed in the use or discharge of firearms/bows and for the use of, or presence at, ranges, buildings, equipment, property, social hall, land, or any activities belonging to TCSL ("Activities") whether as a member, shooter, guest, or participant and for other good and valuable consideration, the receipt of which is acknowledged, I agree to the following Waiver of Liability ("Agreement"):

1. **Waiver and Release of Liability:** My participation in Activities is voluntary and subjects me and my guests to the possibility of physical injury (which could be minimal, serious, and/or result in death) and loss of or damage to my property (collectively, "Risks"). Accordingly, I agree to the following:
  - a) I release, hold harmless and will indemnify TCSL, its officers, board of directors, employees, representatives, agents, volunteers, and contractors (the Released Parties) from any claim, demand, loss, liability, damages, attorney fees and costs whatsoever arising from, related to, or resulting from these Risks, including those caused by the negligent acts or omissions of any of the Released Parties.
  - b) I expressly assume the risk of participating in the Activities and of having my guests participate in the Activities.
  - c) I am solely responsible for any and all medical and related bills that I may incur because of an injury, as well as costs related to loss or damage to my property, that I may sustain as a result of my participation in Activities.
  - d) This agreement shall be binding on my estate, heirs, next of kin, personal representatives, executors, administrators, successors, and assigns, as well as any other party asserting a claim on my behalf or on behalf of my estate and be binding on any of my guests.
  - e) I agree that this Agreement and, when applicable, the attached Parent/Guardian Waiver for Minors are intended to be broad and inclusive as permitted by Michigan law, and that if any provisions of this Agreement or the Parent/Guardian Waiver for Minors is held invalid or otherwise unenforceable, the enforceability of the remaining provisions shall be not impaired.
2. **General Provisions:**
  - a) I expressly agree that (1) this Agreement shall be governed and construed according to the laws of the state of Michigan and (2) any action or proceeding concerning any claim or the meaning or effect of any provision of the Agreement or the attached Waiver for Minors shall be conducted only in the federal or state courts located in Washtenaw County or the Eastern District of Michigan, and I expressly submit to the jurisdiction of such courts.
  - b) This Agreement contains the entire understanding between the parties concerning these matters. No waiver or amendment of any of the terms of this Agreement shall be effective unless made in writing and signed by the parties.
  - c) Photos: TCSL has my permission to use my or my child's photograph publically to promote TCSL. I understand that the image may be used in print publications, online publications, presentations, websites, and social media. I also understand that no royalty, fee, or other compensation shall become payable to me by reason of such use.

I acknowledge that I have read and understand this Agreement and sign it voluntarily. I further acknowledge and agree that I will abide by all TCSL rules, including range rules and procedures, and any other rules and regulations stated by the Released Parties while on TCSL premises.
