President's Column

On August 18, we had our 85th Anniversary Open House. There was free food, ice cream, lemonade, indoor and outdoor games, and music from the Foxtree Folk Band. The event was open to the public, and we did get people from the community who came to visit the Club. Everyone had fun, and the community members were able to inspect the clubhouse, ranges, etc. Val Kabat and Carol Grubb did an outstanding job of organizing the event. There were a lot of other volunteers who also helped set up, keep the event going, and clean up afterward. As always, our volunteers are our biggest asset.

Speaking of volunteers, let me mention Pam Hasselbach, Chair of the Grounds Committee. Since being appointed to her position on the Grounds Committee, Pam has done an outstanding job of improving Tri-County's appearance. Just a few examples: Missing "No Trespassing" signs that were replaced, the flower beds around the clubhouse and gazebo were cleaned up and re-planted, the wall on one of the Action Bays was fixed, a tree stump which was a trip hazard on one of the Action Bays was removed, grass seed was planted, and fallen branches were taken to the burn pile. This is in addition to the usual grounds maintenance, which includes mowing—a LOT of mowing! And the tractor has been fixed! Thanks to Pam's efforts, along with her crew of volunteers, when TCSL hosts the Tier 3 IDPA match in September and participants come from around the state—in fact, from around the country—our curb appeal will be much improved. It also gives our potential members a much better impression of TCSL. Nice job, Pam!!

The Tri-County Sportsmen Challenge (IDPA's Tier 3 Match) will take place on September 13-15. I strongly recommend that you come out and observe this event. Multiple stages will be set up with different scenarios for each shooter to work through. If you have never seen events like this before, you'll enjoy walking around, looking at all of the different stages. (Try to imagine how many volunteer hours went into getting them set up!) You'll understand why some have called this the best IDPA match in Michigan. Steve Nesmith and Earl Austin continue to design and set up the stages,

organize the volunteers, etc. Not only is this a fun and impressive event to watch, it brings in a decent amount of money each year.

TCSL is within 2-3 months of paying off the mortgage. Income has increased, in part due to Nick Coburn's efforts to re-open Trap. Nick and his volunteers have done a great job of getting each event set up properly, and each one has run smoothly. Hall rental and food for these events has continued its tradition with Mark Smokowicz and his crew of volunteers. These events have traditionally generated a nice amount of income for TCSL. Financially, we will be in an excellent financial position at the end of this year as a result of John Harden's and Jim Walter's efforts.

MUCC is raising annual dues, which means that the TCSL Board has a tough decision to make: Should the Club remain an MUCC member? If the answer is "yes," do we need to raise its dues to compensate for the increase?

At its August meeting, the Board agreed to extend Rob Grubb's employment past the original term, which would have ended in September. So Rob will be with us for a while. If you haven't met Rob, come out and talk with him. He is at the Club Wednesday through Saturday from 10am to 6 pm. He is doing a terrific job and is very friendly.

In August, the Board also agreed to start offering a six-month membership, enabling an individual to give TCSL a try before deciding to become a full-time member. Each individual can only purchase the six-month membership once. Next August, we'll evaluate this plan and see if it accomplishes the goal of attracting more new members.

We still need a Kitchen Chair. If we can't fill the position, the Board will have to consider discontinuing hall rental as of January 1, 2025.

These are just some of the many issues dealt with each month at the Board meetings and membership meetings. I certainly did not cover all of them from August. If you would like to keep up to date on TCSL, please join us on the third Thursday of each

month starting at 6:30pm. Remember that you get volunteer hours for coming to the meetings. The next one is on September 19, when there will be both a Board and a membership meeting.

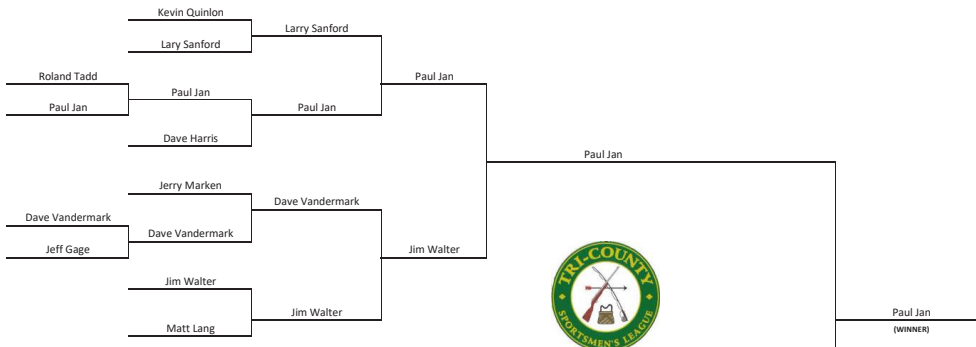

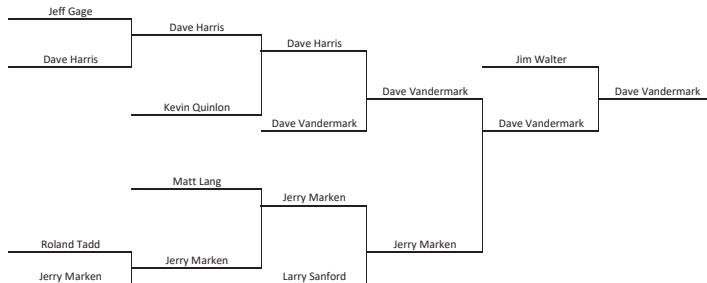

2024 Sportsmen Challenge Match

If I were to tell you that a huge event was coming to our Club, an event that is the largest (more than 200 shooters) of its kind in the Midwest, is considered the best in the country, and has more than 50 sponsors providing close to \$25,000 in prize money, would you stop in to see just what is so special about it? Well . . . the 2024 Tri-County Sportsmen Challenge is all that and more! The event is scheduled for Friday-Sunday, September 13-15.

The place will be a buzz with shooters and staff, and our staff is considered the nicest bunch to run a match. Each shooter will shoot 10 stages on 9 different bays. Every pistol and rifle bay will have its own Course of Fire (COF). Our friendly staff will meet the shooters at first light, check them in, and send them on their way to the shooters' meeting. They won't leave empty handed, though, as each shooter will receive a door prize ranging in value from \$10 to \$2300, a goody bag, and a Match t-shirt. Everybody's a winner before they shoot a round.

Shooting will begin at 10am and will continue till everyone's done (somewhere around 3pm). Food will be served from 11am till 2pm, so shooters can eat (as much as they want) as they go. After the last shot is fired, we will retreat to the clubhouse and reminisce on how the day went. There will be laughing and maybe a little crying when the scores are posted. Food and drink will be available. There will also be a daily drawing for a 50/50 raffle. Past winners have won upwards of \$500. Plaques (\$4000 worth) will be handed out on Sunday, one hour after the last shot.

This match takes a year to plan, and volunteers contribute more than 10,000 work hours.

If you can find the time, please stop in on Friday (safety officers and staff shoot), Saturday, and/or Sunday to see the result of the year-long effort put in by Club and non-Club members. It is simply amazing! Hope to see you on the range,

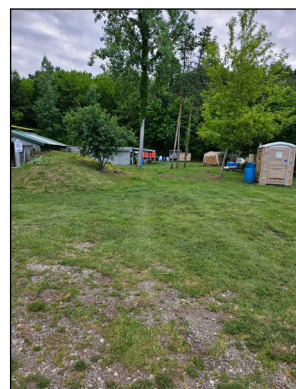

On this Day in History

September 2, 1945 - President Harry Truman declared Victory over Japan Day (V-J Day) commemorating the Japanese surrender to the Allies aboard the USS Missouri in Tokyo Bay.

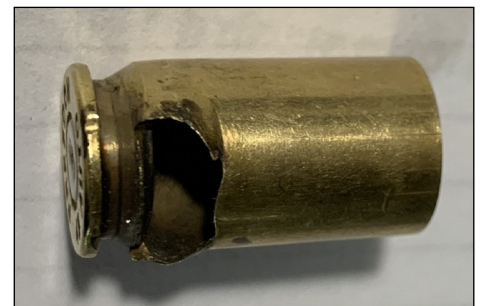
Caution in the Pistol House!

For a number of weeks, I have been finding some 45ACP brass with extreme bulges at the base in the Pistol House. They look to be from someone shooting an older Glock pistol; and they are obviously reloads, because the brand of cases is all over the map mixed together. How can I tell it's a Glock? The firing pin indent is a good indicator. The half-moon "smile" bulge at the base of the case, caused by the unsupported part of the chamber at the 6 o'clock position at the feed ramp, is another. Hotter loads cause the brass to stretch quite a bit here; and while you can get them sized back to fit in the chamber for another loading, the brass has been thinned and work-hardened more than usual. It might not be too much of an issue, unless this same area of the case is fired in the same position in the chamber again. Take a look at the case below that I found in the pistol house. It's a complete case failure. No one wants their gun to blow up in their hand. AND no one wants to be shooting next to the guy who blows up his gun.

So this is just a cautious reminder: If you are shooting reloads, know your gun, know your load, and know what condition your components are in. We don't want to have any accidents on the ranges, especially if they are preventable. This would be very hard not to notice on the firing line, so you might know who this happened to. Maybe it happened to you. Third chances don't come cheaply, so be careful.

By the way, when I find these extremely bulged cases, they go right in the scrap bin. I personally wouldn't use them, and I certainly won't sell them for TCSL to other shooters.
